

# Publishing Agreement for SpringerBriefs

(hereinafter called **Springer**)

on the other part.

## § 1 Rights Granted

1.1 As a result of previous negotiations, Author undertakes to prepare for publication by Springer a work provisionally entitled:

### **Context-aware Collaborative Prediction**

By Shu Wu, Qiang Liu, Liang Wang and Tieniu Tan

(hereinafter called **Work**).

Author will submit a manuscript that will equate to a maximum of 100 printed pages.

If the Work is created in common by two or more persons they are co-authors. Author signs for and accepts responsibility for releasing the Work on behalf of any and all co-authors.

1.2 Author retains the right to communicate with other research colleagues about this Work, to share the Work with them in manuscript form and to host Author's version on his/her own website or his/her institutional repository. Prior versions of the Work can be hosted on non-commercial pre-print servers. In any case of self-archiving or hosting of previous versions of the Work Author will ensure that the Springer publication is always mentioned as the original source of publication and a link is inserted to the published Work on Springer's website. The link must be provided by inserting the DOI number of the Work in the following sentence: "The final publication is available at Springer via <http://dx.doi.org/>[insert DOI from copyright page]".

1.3 Author hereby grants and assigns to Springer the sole right to store the Work electronically in Springer's Online Database, to reproduce, publish, disseminate, sell and licence throughout the world the said Work and parts thereof, including all revisions or versions and future editions, in all forms and media of expression – such as online and print products – now known or developed in the future, as well as to translate, store electronically, publish, disseminate, sell and licence the Work in any foreign languages and throughout the world, during the term of copyright protection. Springer especially has the right to permit others to use individual illustrations, tables or text quotations and may use the Work for advertising purposes. For the purposes of use in electronic forms, Springer may adjust the Work to the respective form of use and include links (e.g. frames or inline-links) or otherwise combine it with other works and/or remove links or combinations with other works provided in the Work. Springer is entitled to post the Work on social media accounts closely related to the Work. For the avoidance of doubt, all provisions of this contract apply regardless of whether the Work itself constitutes a database under applicable copyright laws or not.

1.4 Springer will take, in the name of Author, any necessary steps to protect these rights against infringement by third parties. It will have Author's copyright notice inserted into all editions of the Work according to the provisions of the Universal Copyright Convention (UCC) and dutifully take care of all formalities in this connection in the name of Author.

- 1.5 The parties acknowledge that there may be no basis for claim of copyright in the United States to a Work prepared by an officer or employee of the United States government as part of that person's official duties. If the Work was performed under a United States government contract, but Author is not a United States government employee, Springer grants the United States government royalty-free permission to reproduce all or part of the Work and to authorise others to do so for United States government purposes. If the Work was prepared or published by or under the direction or control of Her Majesty (i.e., the constitutional monarch of the Commonwealth realm) or any Crown government department, the copyright in the work shall, subject to any agreement with Author, belong to Her Majesty. If Author is an officer or employee of the United States government or of the Crown, reference will be made to this status on the signature page.

## **§ 2 Delivery and Acceptance of the Work**

- 2.1 Author agrees to deliver the manuscript to Springer not later than September 30, 2016. The manuscript meets the terms of this agreement only if it satisfies the agreed stipulations as to form, content, and size. Author is responsible for correctness of the manuscript, including content and language. The price, format, manner of presentation and all other aspects of publishing will be determined by Springer. After acceptance of the delivered manuscript, changes of authorship or in the order of authors listed and title changes will not be accepted by Springer.
- 2.2 Author warrants that the Work is original except for such excerpts from copyrighted works (including illustrations, tables, animations and text quotations) as may be included with the permission of the copyright holder thereof, in which case(s) Author is required to obtain written permission to the extent necessary and to indicate the precise sources of the excerpts in the manuscript. Author is also requested to store the signed permission forms and to make them available to Springer if required. Author warrants that Author is entitled to grant the rights in accordance with Clause 1 "Rights Granted", that Author has not assigned such rights to third parties, that the Work has not heretofore been published in whole or in part, that the Work contains no libellous statements and does not infringe on any copyright, trademark, patent, statutory right or proprietary right of others, including rights obtained through licences; and that Author will indemnify Springer against any costs, expenses or damages for which Springer may become liable as a result of any breach of this warranty.

## **§ 3 Author's Discount for Books and Electronic Access**

- 3.1 Author is entitled to purchase for his/her personal use (directly from Springer) other books published by Springer at a discount of 40% off the list price for as long as there is a contractual arrangement between Author and Springer and subject to applicable book price regulation. Resale of such copies or of free copies is not permitted.
- 3.2 Springer shall provide electronic access to the electronic version of the Work on Springer's Internet portal, currently known as SpringerLink, to Author. Furthermore, Author has the right to download and disseminate single chapters from his/her Work created and provided by Springer for his/her private and professional non-commercial research and classroom use (e.g. sharing the chapter by mail or in hard copy form with research colleagues for their professional non-commercial research and classroom use, or to use it for presentations or handouts for students). Author is also entitled to use single chapters for the further development of his/her scientific career (e.g. by copying and attaching chapters to an electronic or hard copy job or grant application).  
When Author is more than one person each of the co-authors may share single chapters of the Work with other scientists or research colleagues as described above. In each case, Springer grants the rights to Author under this clause provided that Author has obtained the prior consent of any co-author of the respective chapter.

## **§ 4 Remuneration**

- 4.1 Springer shall pay to Author a remuneration of 500 USD payable upon publication, publication being stipulated as the point in time when the Work is being distributed in print or electronic form, whichever occurs earlier.
- 4.2 If Springer grants licences to use the Work or derivative works thereof or parts of either in non-Springer products (e.g. a licence to translate the Work and to distribute the translation, or a licence to distribute parts of the Work in a third-party publication), Author's sole payment for the respective licence and any related use will be a share of Springer's Net Proceeds according to industry standards of 50%.
- 4.3. If "Author" comprises several individual authors, the aforesaid remuneration will be paid as a total to the joint group of authors. Each co-author will receive an equal share of any payment.

- 4.4 If there is a legal requirement for Springer to withhold any taxes, the taxes will be deducted from the payments to Author. Authors are responsible for the taxation of their payments. Springer is entitled to report related information (including personal and financial data) to the respective authorities.
- 4.5 Any publisher's proceeds from rights managed by national copyright organisations (collecting societies including but not limited to societies such as Copyright Clearance Center) are the sole property of Springer. Any such author's proceeds are the sole property of Author, and if applicable, registration and taxation of such proceeds is Author's sole responsibility.

## § 5 Competing Works

Author agrees not to release any rival publication with another publisher that may reduce sales of this Work.

## § 6 New Editions

If subsequent editions seem necessary they will be published by Springer. If Author, for whatever reason, is unwilling or unable to submit an updated manuscript or does not do so within a period of three months after being notified by Springer that a new edition is necessary, then Springer is entitled to designate one or more individuals to prepare this and all future editions. In this case, Author does not participate in, or receive payment for, preparing future editions.

## § 7 Entire Agreement

This agreement shall be governed by, and shall be construed in accordance with, the laws of the Republic of Singapore. The courts of Singapore, Singapore shall have the exclusive jurisdiction.

To signify their agreement to the terms outlined herein, all parties have signed and exchanged this contract.
